Approach and Implementation



Handheld MC3390 scanners offer mobility and flexibility, enabling personnel to scan RFID tags on the move.



ZEBRA ZT411 LABEL PRINTERS:

Each office deployed ZT411 label printers to generate RFID labels for document identification and tracking.
